I am to state that the General Body of the Council at its meeting held on 21st & 22nd June, 2001 considered the Council Inspector's report (April, 2001) on the standard of examination and other teaching facilities available at Shri B.M. Patil Medical College, Bijapur for purpose of recognition of M.S.(E.N.T.) qualification granted by Rajiv Gandhi University of Health Sciences, Bangalore. The Committee approved the following recommendation of the Postgraduate Committee which I am directed to convey herewith for your information & necessary action:-

"The Postgraduate Committee considered the Council Inspector's report (April, 2001) and decided to recommend that M.S.(ENT) qualification granted by Rajiv Gandhi University of Health Sciences, Bangalore in respect of students being trained at Shri B.M. Patil Medical College, Bijapur be recognised and included in the 1st Schedule to the IMC Act, 1956 restricting the number of admission to 1(one) student per year.


The Committee further decided to advise the institution to implement the observations of the Council's Inspector in the report."
