Terms and Conditions for Online Payment

The Terms and Conditions contained herein shall apply to any person ("User") using the services of COLLPOLL hereinafter called "COLLPOLL" for making Fee payments through an online payment gateway service ("Service") and Payment Gateway Service provider, through COLLPOLL' website i.e. https://bldeacet.collpoll.com . Each User is therefore deemed to have read and accepted these Terms and Conditions.

In addition to these Terms and Conditions, the terms and conditions of BLDEA (available at T&C Link) shall also apply. By agreeing to these Terms and Conditions, you acknowledge and agree to have read, understood and you consent to be governed by the terms of BLDE Association for the purposes of accessing COLLPOLL.

A. Privacy Policy

COLLPOLL respects and protects the privacy of the individuals that access the information and use the services provided through them. Individually identifiable information about the User is not willfully disclosed to any third party without first receiving the User's permission, as covered in this Privacy Policy.

This Privacy Policy describes COLLPOLL' treatment of personally identifiable information that COLLPOLL collects when User is on the COLLPOLL' website. - 1. Once a User has accepted these Terms and Conditions, he/ she may register and avail the Services. A User may either register on <short form if any else full name of the client>'s website or alternatively enter his/ her Roll number and pay their dues/ fees in any other manner as may be specified by COLLPOLL from time to time.
- 2. COLLPOLL' rights, obligations, undertakings shall be subject to the laws in force in India, as well as any directives/ procedures of Government of India, and nothing contained in these Terms and Conditions shall be

in derogation of COLLPOLL' right to comply with any law enforcement agencies request or requirements relating to any User's use of the website or information provided to or gathered by COLLPOLL with respect to such use. - 5. The entries in the books of COLLPOLL and/or the Payment Service Providers kept in the ordinary course of business of COLLPOLL and/or the Payment Service Providers with regard to transactions covered under these Terms and Conditions and matters therein appearing shall be binding on the User and shall be conclusive proof of the genuineness and accuracy of the transaction.
- 6. Refund For Charge Back Transaction: In the event there is any claim for/ of charge back by the User for any reason whatsoever, such User shall immediately approach COLLPOLL with his/ her claim details and claim refund from COLLPOLL alone. Such refund (if any) shall be effected only by COLLPOLL by means as COLLPOLL deems appropriate. No claims for refund/ charge back shall be made by any User to the Payment Service Provider(s) and in the event such claim is made it shall not be entertained.
- 7. In these Terms and Conditions, the term "Charge Back" shall mean, approved and settled credit card or net banking purchase transaction(s) which are at any time refused, debited or charged back to merchant account (and shall also include similar debits to Payment Service Provider's accounts, if any) by the acquiring bank or credit card company for any reason whatsoever, together with the bank fees, penalties and other charges incidental thereto.
- 8. Refund for fraudulent/duplicate transaction(s): The User shall directly contact COLLPOLL for any fraudulent transaction(s) on account of misuse of Card/ Bank details by a fraudulent individual/party and such issues shall be suitably addressed by COLLPOLL alone in line with their policies and rules.
- 9. Server Slow Down/Session Timeout: In case the Website or Payment Service Provider's webpage, that is linked to the Website, is experiencing any server related issues like 'slow down' or 'failure' or 'session timeout', the User shall, before initiating the second payment, check whether his/her Bank Account has been debited or not and accordingly resort to one of the following options:

- (I) In case the Bank Account appears to be debited, ensure that he/ she does not make the payment twice and immediately thereafter contact COLLPOLL via e-mail or any other mode of contact as provided by COLLPOLL to confirm payment.
- (ii) In case the Bank Account is not debited, the User may initiate a fresh transaction to make payment.

However, the User agrees that under no circumstances the Payment Gateway Service Provider shall be held responsible for such fraudulent/duplicate transactions and hence no claims should be raised to Payment Gateway Service Provider. No communication received by the Payment Service Provider(s) in this regards shall be entertained by the Payment Service Provider(s).

C. Limitation of Liability

- 1. COLLPOLL has made this Service available to the User as a matter of convenience. COLLPOLL expressly disclaims any claim or liability arising out of the provision of this Service. The User agrees and acknowledges that he/ she shall be solely responsible for his/ her conduct and that COLLPOLL reserves the right to terminate the rights to use of the Service immediately without giving any prior notice thereof.
- 2.
